Basic Information and FAQ's

What are the ages for Kids Camp?

- All registered campers must be 7-12 years of age
- Children ages 6 and under may attend evening services **with** a parent or legal guardian free of charge.

When Does Camp Start & End?

- July 13-15, 2022
- Check-in will begin at 9:00 AM. on Wednesday of the Camp.
- Kids Camp ends on Friday Evening. Parents/Legal Guardians are required to pick campers up by 10:00 A.M. Saturday

How Much Does Camp Cost?

- The cost of Kids Camp is \$130 which includes all activities, meals, and a bed in the dormitory . Day Campers registration is \$90 which includes all activities and meals.
- If there are 2 or more campers attending from the same family the cost will be reduced by \$25 per student.
- Registration must be paid online at www.vdcm.online
- Registration is transferable but NOT refundable past July 4, 2022
- There will be no Walk-up/At the Door Registration. This is to ensure we have the appropriate ratio of chaperones per campers.

What Should I Bring?

- Bible
- Linens for single bed, blanket/sleeping bag, pillow, towels, wash clothes, toiletries i.e. (soap, shampoo, toothbrush, toothpaste, deodorant, brush, comb,etc.)
 - Underclothes, pajamas, robes, athletic clothes and sneakers for day attire, business casual clothing for evening attire, sweater or jacket (evenings can be cool)
- Money for offering and spending money for concessions

What's the Registration Process?

- All attendees must be registered online by July 1, 2022 using www.vdcm.online
- Student Application forms must be printed, signed, and turned in during check-in.

Student Conduct Guidelines

1. Students are required to wear their registration band at all times including times of recreation.
2. Kids Camp is a time designated for students to draw closer to God & with other apostolic students therefore, no camper shall have in their possession at any time: Cell phones, Kindles, iPad, Nabi, or video games of any kind.
3. Vile, rude or profane language is prohibited.
4. All students should give respect to the campground buildings and facilities.
5. Only registered students will be allowed at camp during daytime activities. Evening services are open to everyone (**children under the age of 7 must be accompanied by a parent/legal guardian**).
6. Students are required to attend all classes and services as outlined on the camp schedule.
7. Students must show respect to staff and instructors.

Student Dress Guidelines

1. No shorts allowed. Wind pants, slacks, & jeans for boys; dresses or skirts that cover the knee for girls. (Skirts must have tights or shorts underneath)
2. Swimwear is appropriate in the pool area only, and during the designated separated swim time for boys and girls. Robes or other coverings required when walking out to the field during water activities.
3. No ornamental jewelry (necklaces, earrings, rings, bracelets, etc.)
